- **National Dashboard:** ``/`` (Global macroscopic view of the entire DRC, tracking all 26 Provinces and 145 Territories)
- **Executive Analytics & TMS:** ``/tms`` and ``/analytics`` (National aggregate metrics, cross-border TMS integrations, and financial tracking)
- **National Disciplinary & Sanctions:** ``/admin/sanctions`` (Global oversight of federation sanctions and regulatory overrides)
- **Identity & Passports:** ``/passport`` (Unrestricted read-access to every digitized entity in the national registry)

Your Next.js session is elevated with absolute macroscopic read privileges, allowing you to traverse any `[provinceslug]/[cercleslug]` dynamically.

## PERMISSIONS & SCOPE BOUNDARIES

### AUTHORIZED CAPABILITIES

- **Macroscopic Oversight:** Monitor real-time compliance metrics, registration totals, and fee aggregations at the national level.
- **Strategic Overrides:** Apply and lift national-level ``federationSanctionId`` blocks on leagues, cercles, or specific clubs.
- **National Approvals:** Serve as the final escalation and approval authority for international transfers, high-profile registrations, and structural DB seeding.
- **Systemic Auditing:** Review the immutable audit logs for all lower-level operations to ensure local entities are strictly enforcing FIFA mandates (e.g., verifying ``cpeRecords``).

### WHAT THIS ROLE CANNOT DO

- **You cannot** perform daily low-level data entry (e.g., uploading standard medical certificates); this compromises the SoD (Segregation of Duties).
- **You cannot** bypass the core architectural logic gates, such as allowing competition entry without a valid ``paymentTxId`` or a verified ``digitalPassportId``.
- **You cannot** alter the structural DTO bindings mapping Territories to Provinces without DBG engineering escalation.

## MAIN SCREENS & DUTIES

## 1. THE NATIONAL DASHBOARD

The core executive command center. It visualizes the entire structural mapping of the country. It highlights "empty" states (inactive Cercles) and tracks national compliance percentages to provoke strategic interventions.

The interface for applying overarching regulatory blocks. Duty: Ensure bad actors are universally blacklisted across all localized /registration and /match-reports routes.

## IDENTITY AND PASSPORT GUIDANCE

- `nationalId`: The foundational Congolese governmental identifier linking the digital profile to a physical citizen.
- `careerNumber`: The immutable, lifespan identifier generated uniquely for each participant.
- `digitalPassportId`: The finalized, verified digital token signifying a player is completely legal, medically cleared, and sanctioned to participate.

Leadership Mandate: Enforce the absolute requirement that no entity bypasses this trifecta. The integrity of the DRC on the global stage depends on a zero-tolerance policy for duplicate or falsified identities.

## COMMON MISTAKES AND KEY ALERTS

- **\*\*Ignoring Dashboard Voids:\*\*** Failing to investigate massive regions showing 0 active registrations.
- **\*\*Overriding Without Documentation:\*\*** Lifting sanctions without ensuring the requisite offline judiciary paperwork is archived in the Hub.
- **\*\*Session Delegation:\*\*** Allowing subordinates to operate under Executive credentials, destroying the integrity of the RBAC audit logs.
